**ADMINISTRATIVE ORDER
NO. 14-09 A2
(amending AO NO. 14-09 A1)**

**IN RE: SECOND AMENDMENT TO
ADMINISTRATIVE ORDER 14-09 A1**

WHEREAS, in an effort to conserve judicial resources and promote an efficient determination of actions in the Probate Division, it was determined, via Administrative Order No. 14-09, that whenever a probate case is filed with the Clerk of the Courts, a notice of related cases form must accompany such filing;

WHEREAS, Administrative Order No. 14-09 attached a form Notice of Related Probate Cases and required that it accompany the initial pleading filed in a Probate case;

WHEREAS, the Court has determined that, in addition to being informed of related Probate cases, Probate judges should also be informed of related cases from other Divisions and Jurisdictions, including civil cases and criminal cases; and

WHEREAS, the Court has determined that it is necessary to further amend and clarify the Notice of Related Probate Cases form attached to Administrative Order No. 14-09 A1;

NOW, THEREFORE, pursuant to the authority vested in me as Chief Judge of the Eleventh Judicial Circuit of Florida, under Rule 2.215, Florida Rules of General Practice and Judicial Administration, it is hereby **ORDERED** that:

1. In addition to related probate cases, the parties shall have a duty to inform the court of any related cases that are pending or filed in any Division within the Eleventh Judicial Circuit of Miami-Dade County, any Division in any other Circuit in Florida, any Appellate State Court, any Federal Court, and in any other State, including civil cases in which the decedent, estate, trust, or beneficiaries have an interest, and criminal cases which have a connection to the probate case (e.g. if a ward is arrested, or a fiduciary has a pending criminal matter).
2. Although related Probate cases shall continue to be transferred in accordance with paragraph 5 of Administrative Order No. 14-09, related cases from other Divisions shall not be transferred.
3. The Probate Notice of Related Cases form attached to this amendment shall replace the form attached to Administrative Order No. 14-09 A1 and shall be utilized henceforth.
4. The requirement set forth in paragraph 2 of Administrative Order No. 14-09 A1, that “[e]ach

party shall have a continuing duty to inform the court of any related proceedings and must therefore submit separate or joint supplemental notices as related cases become known or reasonably ascertainable,” is not limited to cases filed in the Probate Division, but shall apply to related cases as described in Paragraph 1 above. Therefore, the attached Probate Notice of Related Cases form must accompany the initial pleading, but also must be filed when a new related case is filed. (For example, if a Personal Representative or Guardian files suit, or if the Estate or Ward is sued, that related case must be noticed.)

5. In addition, within thirty (30) days of the execution of this Administrative Order, parties to open and pending Probate cases which have a related case or related cases that have not already been noticed shall file the amended Probate Notice of Related Cases listing all such cases.
6. Except as amended herein, all other terms and conditions of Administrative Order No. 14-09 remain in full force and effect.

This Administrative Order shall become effective immediately upon execution and shall remain in effect until further order of the Court.
