OF THE CITY OF MIAMI BEACH, FLORIDA
CANVASSING BOARD FOR THE
DECEMBER 6, 2022, RUN-OFF ELECTION**

WHEREAS, on November 8, 2022, the City of Miami Beach, Florida will be conducting its Special Election for the purposes of electing a person to fill the vacancy in City Commission Group II, as well as presentation to City Voters of eight ballot questions; and

WHEREAS, in the event a Run-off Election is needed, the City will conduct said election on December 6, 2022; and

WHEREAS, pursuant to State of Florida election laws, the City is required to designate a Canvassing Board for the Run-off Election; and

WHEREAS, pursuant to City of Miami Beach Code Sec. 38-8, the undersigned was requested to make the following designations to serve on the Canvassing Board of the City of Miami Beach, Florida for the December 6, 2022, Run-off Election (if necessary): one (1) county court judge to serve as a "regular member"; one (1) county court judge to serve as a "substitute member"; and

WHEREAS, the **HONORABLE RAUL ANTONIO CUERVO** is available to serve as the Regular member; and

WHEREAS, the **HONORABLE JEFFREY MICHAEL KOLOKOFF** is available to serve as the Substitute member; and

WHEREAS, the Canvassing Board will convene on December 6, 2022, for the Run-off Election (if necessary), and for all other meetings convened by the Canvassing Board pertaining to said elections.

NOW, THEREFORE, pursuant to the authority vested in me as Chief Judge of the Eleventh Judicial Circuit of Florida, under Rule 2.215, Rules of General Practice and Judicial Administration, the following judicial officers are hereby appointed to serve as members of the Canvassing Board for the Run-off Election and all proceedings relative thereto:

1. Judge Raul Antonio Cuervo is hereby designated to serve as the Regular member and Judge Jeffrey Michael Kolokoff is hereby designated to serve as the Substitute member of the City of Miami Beach, Florida Canvassing Board for the Run-off Election scheduled for December 6, 2022 (if necessary).
2. In their respective capacities, Judge Cuervo will attend all meetings convened for the Canvassing Board and are hereby authorized to sign all documents pertaining to said elections as required or as authorized by law.
3. In the event Judge Cuervo is unavailable to serve, Judge Kolokoff will serve in his stead.
