ASSIGN PETITIONS TO THE
APPROPRIATE RELATED MENTAL
HEALTH CASE OR DIRECTING THE
FILING OF A MENTAL HEALTH
RESTORATION CASE WITHIN THE
PROBATE DIVISION**

WHEREAS, in an effort to conserve judicial resources and promote an efficient disposition of actions in the Probate Division, whenever a Petition for Restoration of Capacity or Suggestion of Capacity is filed with the Clerk of the Courts, it has been determined that a Notice of Filing a Petition for Restoration of Capacity form must accompany such filing; and

WHEREAS, it is further determined that such notice and filing shall be assigned to the appropriate related mental health case. If no Mental Health Case exist, the Petitioner/Filer must file a Restoration Case. For purposes of this administrative order, the term "mental health related case" means proceeding in which a petition to determine incapacity (section 744.3201, Florida Statutes) or a suggestion of capacity (section 744.464, Florida Statutes) has been filed and the subject of the petition or suggestion is also the subject of an open Guardianship Case;

NOW, THEREFORE, PURSUANT TO the authority vested in me as Chief Judge of the Eleventh Judicial Circuit of Florida, under Rule 2.215 of the Florida Rules of Judicial Administration, it is **ORDERED** that the following procedures shall be followed when filing a Petition for Restoration of Capacity or Suggestion of Capacity in the Probate Division:

1. The attached Notice of Filing a Petition for Restoration of Capacity must accompany the Petition for Restoration of Capacity or Suggestion of Capacity by the petitioner. The petitioner shall submit the Notice of Filing at the time of the filing of the petition.
2. Unless otherwise ordered by the Administrative Judge of the Probate Division, the Clerk of the Courts, upon receipt and review of a Notice of Filing a Petition for Restoration of Capacity, is hereby authorized and directed to automatically assign the Petition or Suggestion to the appropriate Mental Health related case or if no Mental Health Case exist, the Petitioner/Filer must file a Restoration Case.

3. The Clerk of the Courts shall review the attached cases whereby a Petition for Restoration or a Suggestion of Capacity was filed during the timeframe of 2010 through February 5, 2021. If so determined, the Clerk shall assign the Petition or Suggestion to the Mental Health Case, as referenced by the Clerk's docket number.

This Administrative Order shall become effective immediately upon execution and shall remain in effect until further order of the Court.
