**ADMINISTRATIVE ORDER

**IN RE: TRANSFER OF IDENTIFIED
CASES FROM SECTION 58 OF THE
HIALEAH COURTHOUSE TO SECTION
HI 02 OF THE HIALEAH COURTHOUSE,
DOMESTIC VIOLENCE DIVISION**

WHEREAS, the Court has determined it is necessary to transfer identified domestic violence cases from Section 58 of the Hialeah Courthouse to Section HI 02 of the Hialeah Courthouse, Domestic Violence Division, for the purposes of judicial efficiency.

NOW, THEREFORE, pursuant to authority vested in me as Chief Judge of the Eleventh Judicial Circuit of Florida, under Florida Rules of General Practice and Judicial Administration, it is hereby **ORDERED**:

1. All pending cases assigned to Section 58 of the Hialeah Courthouse shall be reassigned to Section HI 02 of the Hialeah Courthouse, Domestic Violence Division.
2. The Clerk of the Court shall make a one-time transfer of open domestic violence cases, as identified on the attached list, from Section 58 of the Hialeah Courthouse to Section HI 02 of the Hialeah Courthouse, Domestic Violence Division.
3. No case shall be transferred to Section HI 02 unless it complies with the criteria established herein.
4. The Deputy Chief Judge or designee may at any time, on the Court's own motion, assign a case to another section in the interests of justice or to promote the efficient operation of the Domestic Violence Division.

This Order shall become effective immediately upon signing and shall remain in effect until further order of the Court.
